BECOME A STAR AT THE HISTORIC CROSSING CAPRI NAPLES

REGULATION

The Organizing Committee (OC) of the race Capri-Napoli, on 2020 will promote two "open" unofficial tests ".

1) The competition is not to be construed in any way as race;

2) The competition is reserved for Italian athletes and for athletes of other nations;

3) The competition will be held on June 26 and on July 10, 2020 with the possibility, if necessary, of adding another possible date;

4) The competition involves swam from Capri to Naples for a distance of 36 km;

5) The registration can only be made by completing the appropriate form which must be received no later than January 31, 2020 The CO reserves the right to accept and confirm the swimmers selected no later than February 2, 2020. Once confirmation is received from the CO participants will be able to pay the registration fee disclosed, including any special needs and / or additional services;

6) The registration shall be deemed completed only when the CO receive all the required documents to the participants;

7) The competition will involve participation of three categories:

- SOLO
- DOUBLE

- RELAY (with a number of athletes including from 3 to 6 for each relay. For safety reasons, in the case of relay of 6 people, is not provided, to the edge of the support boats, the presence of the coach/handler);

8) For the category SOLO, swimmers will have to prove that they have already swam race for at least 20-25 km, indicating the relative times;

9) For the category SOLO, will be applied the FINA rules for the open water competitions with distances over 15 km. Only for what concerns the rules about costumes approved, the O.C. reserves derogations from the current legislation;

10) For the category SOLO, will be applied the FINA rules for the open water competitions with distances over 15 km, with specific additions rules related to the changing that will be made known to the participants prior to participation. Only for what concerns the rules about costumes approved, the O.C. reserves derogations from the current legislation;

11) For safety reasons, the O.C. establishing a maximum number of 30/35 participants defined as follows:

- Solo Category : up to a maximum of 10 athletes;
- Duo Category: up to a maximum of 2 teams (4 athletes);
- Relay Category: up to a maximum of 5 or 6 relays (20-26 athetes).

The C.O. reserves the right to amend the number of participants in relation to the persistence of the same conditions of safety at sea;

12) For safety reasons, the O.C. establishes a time limit fixed in 10 hours. At the end of which all swimmers must finish the race and go back on his support boat, otherwise the payment of a fixed penalty, as of now, at \in 500;

13) In case, for reasons of bad weather, competition could not be realized, O.C. will make a race course in Naples, under the coast, over a distance of 15 and 20 km;

14) The competition includes an application fee that entitles you to a range of benefits as follows:

- Merchandising and official gadgets for swimmers and coach;
- Local transport (only in case of accommodation at the official hotel);

- Travel expenses (ferry or hydrofoil) for 2 persons (category SOLO), for 3 persons (category DUO) or by the number of participants in the relay category plus a coach (up to 5 athletes, if the relay is made up of 6 athletes, it is not present the coach on board. **Journey is meant only in the days and times indicated by the O.C.**:

- Rent of an escort boat for the race with driver and fuel enough to make the crossing;

- "Meal" for boat occupants, consisting of sandwiches and / or sandwich with water and / or iuice;

- Safety boats at sea;

- Medical care;
- Event Insurance coverage;

- Determination of the official time;

- Judge (only for category SOLO);

- Registration of the name of the swimmer (only for category SOLO) in the appropriate category on the official site: www.caprinapoli.com;

- Certificate of Participation, official photos and prizes (not cash);
- Assistance on arrival of the race;

15) The registration fee must be received no later than the following deadlines will be excluded from the competition:

- \in 200 upon receipt of confirmation of the possible acceptance at the competition, without waiting for the deadline of January 31, 2020;

- Not later than January 31, 2020 (up 50% payment)

- April 30, 2020 (balance payment).

16) For the category SOLO, only for competitive athletes, the O.C. reserves, in the case of an excellent performance in terms of time, to accept the official race Capri-Napoli 2020 scheduled for

September 1st/8th, the athlete that will be implemented and that will have the power to accept the invitation at its discretion, covering, however, its cost of participation;

17) The final results will be prepared for the two categories and will be published immediately online on the website www.caprinapoli.com;

18) All trophies, awards, results and any gadget will be delivered in ways, places and times established by the organization, who shall give notice in a timely manner;

19) The timing will be manual;

20) For safety reasons, at any time prior to the competition or the same year, at the discretion of the O.C. reserves the right to cancel or suspend the event. In case of interruption during the competition, the swimmers are required to comply immediately with the decision of the O.C.

21) With the acceptance of registration, each participant declares to be aware of this Regulation, Regulation FINA and the FIN on the subject and raises and frees the Organizing Committee of the event, the promoters, the town of Capri and Naples, all sponsors of the event, their representatives, successors, officers, directors, members, agents and employees of the companies mentioned above, from any liability of any kind, known or unknown, arising out of participation in the event. The participant grants, moreover, without remuneration, the permission to use photographs, videos, etc.. relating to its participation in the event to all the entities listed above for any legitimate use;

22) The Organising Committee shall, upon request, a list of participating hotels in Naples / Capri or from whom you can get the price in convention by making a reservation through the O.C.
